The Tyne Theatre and Opera House Preservation Trust is an independent charitable organisation dedicated to the preservation, restoration and sustainable operation of the Tyne Theatre and Opera House – a magnificent Grade I listed building dating from 1867.

Our mission is to protect, preserve and celebrate the heritage of this iconic building, ensuring it continues to serve as a vibrant venue for live performance, creative learning, and community engagement.

Working in partnership with our operating company, the Trust plays a crucial role in fundraising, advocacy, strategic development, and oversight of major capital projects.

Our recent achievements...

In recent years, the Trust has made significant progress in strengthening the theatre's position both culturally and financially. Highlights include:

- Securing major funding from the National Lottery Heritage Fund and other partners for restoration and improvement works.
- Completing significant heritage and audience development projects, including the Gallery Reseating Project, which transformed the auditorium and increased capacity.

The Role of Chair

The Chair will lead the Board of Trustees in setting and overseeing the strategic direction of the Trust, working closely with the Chief Executive and fellow Trustees to ensure the charity fulfils its mission and operates with integrity, effectiveness, and ambition.

This is a role for a highly engaged leader who can dedicate time and energy to both governance and hands-on involvement, offering more active support than is typically expected of a Trustee. The successful candidate will act as a visible champion for the Trust, fostering strong partnerships, guiding strategic development, and supporting the Chief Executive and team to deliver major initiatives.

Key Responsibilities:

- Lead the Board in providing strategic guidance, oversight, and governance.
- Work closely with the Chief Executive as a trusted partner, providing constructive challenge and support.
- Represent the Trust publicly, building and maintaining relationships with stakeholders, funders, and partners.
- Actively contribute time beyond formal meetings, engaging directly in advocacy, development, and major projects.
- Ensure the Board operates effectively, promoting a culture of openness, collaboration, and accountability.

Our Executive Team and officers of the Trust will support our new Chair to ensure they understand their responsibilities in accordance with the charity's Articles and Objectives.

Training will follow the Charity Commission guidance and offers a 'core syllabus' covering the basics of charity governance that all Trustees should be familiar with.
